Thank you for your interest in our **NSW pre licencing course, Statement of attainment from Certificate II Security Operations** course.

Courses are held at our Fairfield Training Centre, level 2, Suite 7, No 1 The Crescent, Fairfield, across from the Fairfield Hotel. Entrance is off Hamilton Road.

Course duration is for a 1A/1G/1C is ten days, Monday – Friday, 2 weeks consecutively.

The cost of a 1A/1G/1C Security course is \$650 per person.

If you require a **Senior First Aid Certificate** (*which is a pre-requisite when applying for a Security Licence*) the total cost is \$700 (Apply First Aid and held on Saturdays, unless otherwise notified)

**To apply:**

- Complete the enclosed application form
- Read "Fact sheet 6" available on the home page of our website
- Complete in full a "P1016" also available on our website homepage
- Return both "P1016" and application form to our office, in person or by fax or post (details below)
- with one of the following documents:

**Certified copy of an Australian Birth Certificate OR  
Certificate of Australian Citizenship  
Certificate of Evidence Resident Status (Form 283) OR  
Certified copy of Australian Driver's Licence**

**For New Zealand applicants:**

**Certified copy of your passport, showing passport number, name & date of birth, issue & expiry date, and photograph is required.  
Certified copy of visa page, clearly showing Immigration Australia stamp with date of arrival in Australia**

**NB: All applicants must be Australian Citizens or a Permanent Resident of Australia**

All applicants must undertake a Language, Literacy and Numeric assessment before commencing training; competency will determine suitability to continue on training. This is a legal requirement.

The results of this test will be stored and may be shared with the SIR (Security Industry Registry)

### **How do you get a full unrestricted licence?**

When you start work with a Security company, you will have to continue your training for 12 months in order to gain the qualification needed to be eligible to apply for a full unrestricted Class one security licence.

The additional training you undertake will depend on what class of licence you want to gain but will be at either a Certificate II or Certificate III level.

### **How does the unrestricted training take place?**

Training will be done on the job. You may be required to consult with other guards or by working on your own to complete assignments or projects.

Your employer may pay for this training, if not will be required to pay for any additional training yourself.
